



Academy of Art University Notice at Collection of Personal Information

Academy of Art University (“the Academy,” “the University,” “we,” “us” or “our”) provides this Notice at Collection for Consumers (“this Notice”) as a supplement to the information in our Privacy Policy as required by the California Consumer Privacy Act of 2018 (“CCPA”). The terms defined in the CCPA have the same meaning when used in this Notice. Our Privacy Policy can be found [here](#). This Notice applies to California residents.

Academy of Art University seeks to protect your personal and private information. For business purposes, we ask consumers for information that will enable us to provide them with our educational programs and services. The Personal Information (PI) that we collect directly from consumers is for official University use only.

This Notice describes how we collect and use PI, the categories of PI we collect, and instances in which the Academy may disclose PI to third parties. The University only collects and processes PI in accordance with this Notice, unless otherwise required by law.

Categories of Personal Information Collected and Its Use

Academy of Art University collects and processes information from consumers for legitimate business purposes, and when necessary, to comply with local, state, and federal legal obligations.

Application Information

To evaluate candidates for admission, provide requested services, and create, maintain, and secure online accounts with Academy of Art University, we collect applicant PI such as names, citizenship, mailing address, phone number, email address, password for application portal, parent/guardian contact information, date of birth, social security number, military status, gender, ethnicity, race, educational history, and credit card information

Enrollment Information

In order to enroll students in the University, we collect names, email address, phone number, mailing address, program, initials, and signature. PI collected during the enrollment process is used to execute an enrollment agreement (contract) with a prospective student.

Financial Aid Information

To evaluate whether an applicant is eligible to receive financial aid, the University collects names, mailing address, social security number, date of birth, phone number, driver’s license number, driver’s license state, email address, citizenship, alien

registration number, marital status, state of residence, gender, criminal convictions, educational information, income tax return information, military status, parent/guardian information, emancipated minor information, unaccompanied youth information, household information, signature, parent/guardian signature, and loan information.

Veterans' Information

To facilitate students' VA enrollment certification, the Academy collects names, VA file number, mailing address, social security number, type of training, parent school letter status, Yellow Ribbon Recipient status, zip code, and signature.

Registration Information

To register current and prospective students in courses, Academy of Art University collects names, date of birth, birth gender, addresses, phone numbers, email addresses, medical accommodation, medical documentation, gender identity, health insurance policy number and provider, emergency contacts information, and credit card/debit card information.

Housing Information

To provide prospective and current students with housing and meal plans, the University collects names, date of birth, birth gender, addresses, phone numbers, email addresses, medical accommodation, medical documentation, gender identity, health insurance policy number and provider, emergency contacts' phone number and address, and credit card/debit card information.

Online Education LMS Profile

To provide online courses and academic status information to current students, the Academy collects photos, username, phone number, location, website, social media links, portfolio, email addresses, major, biography, resume, grades, attendance, and any PI provided by a student in an online class.

Contact Information

To provide consumers with information about our educational programs and services, the University collects names, email address, country, highest level of education, year of graduation from high school, mailing address, city, state, zip code, phone number, and military status.

Requests for Student Services

To provide students with technical, academic, and career services assistance, the Academy collects names, phone numbers, email addresses, degree program, courses, instructor's name, and first language.

Alumni Placement/ Employment

To comply with state and federal reporting requirements for placement (employment), we collect names, employment status, phone numbers, email addresses, program of study, degree earned, graduation date, graduation term, type of employment, employer name, job title, start date, end date, salary, signature, location, supervisor contact information, continuing education enrollment status, and IP address.

Employee and Job Applicant Information

For human resources, employment, and benefit administration purposes, the University collects personal identifiers, financial, benefit selection, protected classification and diversity information, professional and employment history, education, health and safety, beneficiary, and emergency contact information.

Usage Data

To gather usage statistics to improve our website experience, the Academy collects users' IP address, browser type, operating system, device identifier, device model, software version, or mobile or ISP carrier information, date and time of visit, and user activity on the website.

Disclosure to Third Parties

Our Service Providers receive only the information that is reasonably necessary and proportionate for them to perform services for Academy of Art University. Unless required by law, the Academy does not disclose PI to third-parties; however, the University reserves the right to make exceptions when it is believed that an emergency, illegal activity, or some other reasonable basis exists for providing such information to the appropriate authorities. These exceptions include:

- To comply with a civil, criminal, or regulatory inquiry, investigation, subpoena, or summons by federal, state, or local authorities
- To cooperate with law enforcement agencies concerning conduct or activity that the business, service provider, or third party reasonably and in good faith believes may violate federal, state, or local law
- To exercise or defend legal claims

The Academy prohibits our Service Providers from retaining, using, disclosing, or selling any Personal Information that we share with them for any purpose other than performing the services specified in our contract with that entity.
